- -ONLY members of the KUSA shall be entitled to enter dogs in their registered ownership in any Championship dog show licensed by the KUSA.
- -No RAF/TAF Entries will be permitted.
- -Exhibit numbers are to be collected from the show office on the morning of the show
- -Exhibitors to be present from 8h30
- -Puppies under 4 months are not eligible for exhibition
- -The mating of Bitches within the precincts of the Show is prohibited.
- -No animal other than the exhibit entered may be on the show grounds.
- -Conditions attracting immediate disqualification are set out in Schedule 3, Regulations 7 & 31.

This show will be held under the Rules and Regulations of the Kennel Union of Southern Africa. All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. All exhibits must be on leads at all times unless otherwise instructed by a judge. Bitches in Season are allowed in Breed Classes only. Right of admission reserved. The committee reserves the right to appoint alternative judges at its discretion.
