**RULES**

This show will be held under the Rules and Regulations of the Kennel Union of Southern Africa. Conditions attracting immediate disqualification are set out in Regulations 7 & 31 of Schedule 3.

All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. All exhibits must be on leads at all times unless otherwise instructed by a judge. The mating of bitches within the precincts of the show is forbidden. No entries with RAF or TAF will be accepted. Bitches in season will be permitted to compete in Breed Classes only. The committee reserves the right to appoint alternative judges, to withdraw judging contracts and to combine groups at its discretion.

**COVID-19**

KUSA appeals to attendees at all licensed events to keep up basic precautions whenever possible to prevent a surge of infections, including:

- **Wearing a mask that covers your nose and mouth**  
*Masks are no longer obligatory outdoors, but **must be worn indoor public spaces** – this includes the Organiser's Office at KUSA licensed events whether in a building or marquee.*
- **Keeping a safe distance from others and avoiding crowded areas**
- **Washing or sanitising your hands regularly**

All venues are limited to 50% of their capacity with an upper limit of 1000 indoors and 2000 outdoors (unless proof of vaccine or negative COVID test is required, in which case there is no upper limit).
